## **Clarifying the Columbia Basin Endorsement Fee**


Too often I hear people, many of which are CCA Oregon members, incorrectly discuss the merits of the Columbia Basin Endorsement (CBE) fee. I wanted to take this time to clarify a lot of misunderstandings.

To begin, the CBE has funded much of the Columbia River Gillnet Reforms of 2012. The main use of the fund is to produce more hatchery fish so we wouldn't lose any of the spring Chinook that were historically planted in the Willamette River system.

The Columbia River Gillnet reforms were created by a bi-state work group that proposed sweeping changes to harvest in the mainstem Columbia River in 2012 that included transitioning gillnets off the mainstem Columbia River and prioritized "selective recreational fishing" for the management of the mainstem below Bonneville Dam. Commercial fishing was to be focused on the off-channel terminal areas where very low numbers of wild fish exist, and heavy production and harvest of salmon could still take place using gillnets. The work group presented its plan to both the ODFW and WDFW commissions; each adopted the new plan in 2012 and 2013.

In 2013 Senate Bill 830 in Oregon codified the agreement.

Let's Not Let It Happen



Green Peter Drawdown is One Method Wild Fish Only Advocates Want to Cut Hatchery Production,

Wild fish only advocates continue to take advantage of the legal system to further their misguided agenda. I want to believe that these organizations are genuinely interested in increasing wild fish numbers, but it's difficult to believe that is their real goal given how they go about their business.

I'm sure that many of you have heard about the recent drawdown of Green Peter Reservoir. This action, taken by the US Army Corps of Engineers (USACE), was the result of a lawsuit filed by the Native Fish Society, Northwest Environmental Defense Center and Wild Earth Guardians.

The lawsuit is based on a 2008 Biological Opinion (BiOp) that required the USACE to take 96 actions within a 15-year window intended to benefit Spring Chinook in the Upper Willamette Basin. According to Greg Taylor, Fisheries Biologist for USACE, 87 of those actions were accomplished. He pointed to the need for more time and funds to complete the remaining nine.

Holding government agencies accountable is a good thing and at first glance many will agree that finding a way to get juvenile spring Chinook and winter steelhead past the Green Peter dam safely needs to happen. But here's the deal, the Green Peter Dam, built in 1966, stopped migration of wild fish above that point without assistance. To get above the dam fish had to be trapped and hauled, and according to Taylor that system didn't work primarily because water temperatures were too cold.

## **Pro-Cure Tour**

On a cold December morning last year, several members of the Willamette Falls Chapter met at the Pro-Cure factory in Salem for a tour. We were hosted by Steve Lynch, Director of Operations.

As we walked through Pro-Cure, Steve graciously took the time to explain the entire process of transforming natural fish and chemicals into world-class products that have helped to refine modern recreational fishing today. Pro-Cure is clearly a Pacific Northwest success story.

In 1984 Phil Pirone started Pro-Cure in his basement. At that time Pro-Cure was the first commercially-made egg cure in the US. By 1988 Phil moved into a small commercial unit with four employees and manufactured Pro-Cure Original Egg Cure and several bait oils.

A major bump in the road was a fire in 2001 that burned Pro-Cure to the ground. Rising from the ashes and getting Steve Lynch on board, Pro-Cure started over that same year at a new location in Salem. Steve helped set up the new building and operations.

In May of 2021 Pro-Cure moved to a much larger facility in Salem which was the one we visited. Today, approximately 20 employees run the current operation. Pro-Cure has over 550 products and sells to every major distributor in the US and in 45 countries throughout the world. Amazon is currently Pro-Cure's largest single customer.

As Pacific Northwest recreational anglers, we collectively take off our hats to Pro-Cure and the quality products they make!

Jerry Massey Getting Chummy

Editor's Note: This past November we received this letter from Jerry Massey about his time spent volunteering at the Big Creek Hatchery on the lower Columbia River.

When the boat is on the trailer and the rods are back hanging in their rack, I tend to look for volunteer projects at various hatcheries to go to and work a couple days a week. Hatcheries this time of year are a blur of activity and always looking for volunteers. This year through the mailing to the state board members, Jim Marquoit sent a contact for an ODFW biologist working at the Big Creek Hatchery. Kelcee Smith, Ph.D., is the ODFW state coordinator to reintroduce chum salmon back into Oregon's coastal rivers and streams. Big Creek is also the only hatchery in Oregon that has an ongoing chum broodstock program. It is a robust hatchery that releases spring and fall Chinook, coho, steelhead and chum.

If you have never caught a chum salmon you are missing a treat not experienced by most anglers. Although not known as good table fare and not a species you are able to retain anyway, they are by far one of the hardest fighting salmon that you will catch. They are beautifully marked matching the fall colors flashing green, gold and purple vertical striping. The males have mouths full of protruding teeth. A truly beautiful fish that I have caught numerous times along the North Coast of Oregon. A treat to just catch and release.

#### Plan Your Steelhead Fishing to What The River Presents

While we're watching winter fade to spring, there's several months of steelhead left on the calendar. There's also several months where water conditions will affect how you approach a steelhead run. The simplest bit of advice I can offer is to pay close attention to water conditions and levels. Both can be critical and learning how to fish different water levels takes time to learn. Here are some shortcuts that might help.

In high water, you want to fish on the edges of the fast water; think of walking speed water whenever you look at a section of river with current flow. Pick the slower water just inside the fast water. Steelhead move their way upriver in high water with the least resistance and this is where they'll likely be found.

As the water level drops, remember that same walking speed tip. In low water, that walking speed concept still applies only the steelhead will generally push out to the main river channel.

Another tip I learned years ago from a very experienced steelhead fisherman was when the river is high, fish low and when the river is low, then fish high in the holes.


